Source Water Assessment

The source water assessment for our supply has been completed by the Illinois EPA. Source of Water: WALNUTBased on information obtained in a Well Site Survey published in 1992 by the Illinois EPA, several potential secondary sources are located within 1,000 feet of the wells. One potential secondary source is within the minimum setback zone of Wells #5 and #7. Based on information provided by Walnut's water supply officials, the following facilities, also indicated as potential sources of contamination in the site data table and indicated on the map, have changed status: Walnut Express Lane changed name to Minute Mart, Minute Mart changed name to Walnut Express Lane, and Unknown Bulk Fuel Storage has been removed. The Illinois EPA has determined that the Walnut Community Water Supply's source water is not susceptible to contamination. This determination is based on a number of criteria including: monitoring conducted at the wells; monitoring conducted at the entry point to the distribution system; and available hydrogeologic data on the wells. Furthermore, in anticipation of the U.S. EPA's proposed Ground Water Rule, the Illinois EPA has determined that the Walnut Community's wells are properly constructed with sound integrity and proper siting conditions; a hydrogeologic barrier exists which should prevent pathogen movement; all potential routes and sanitary defects have been mitigated such that the source water is adequately protected; monitoring data did not indicate a history of disease outbreak; and the sanitary survey of the water supply did not indicate a viral contamination threat. Because the community's wells are constructed in a confined aquifer, which should prevent the movement of pathogens into the wells, well hydraulics was not considered to be a significant factor in the susceptibility determination.
